A legal forum recently contained a short update on Govt.'s position regarding the report on local govt. ethics issued a year ago by the Committee for Standards in Public Life which may be of interest "civil servants expect there to be a major cabinet reshuffle soon and are awaiting that before briefing the minister on a response to the CSPL report. We cannot give any assurances as to the Government's position on the report but there is greater support now in the LGA for effective sanctions than there has been previously."

Environment Bill

DEFRA are reintroducing an Environment Bill into Parliament later today. There is more detail at the link and past experience suggests that further topics will be added during its passage through Parliament
